At City Hall, we welcome your pets, but we require permits that you can conveniently obtain at our office. You have the option of one-year, three-year, or lifetime permits, and we offer discounts for Seniors and Disabled individuals.

Why should you license your dog? The proceeds from dog licensing are instrumental in funding vital services that benefit both pets and people. These funds support animal control efforts, ensuring lost pets find their way home and serve as a tool for addressing public nuisance issues, as per the city code.

2021 State Building Code Adoption - revised schedule

The State Building Code Council voted on September 15, 2023, to delay the effective date of the 2021 Washington State codes.

The new code effective date will be **March 15, 2024.** The previous effective date was October 29, 2023 and July 1, 2023 respectively.

Budget Pay for Utilities

We have some exciting news that could make managing your household expenses easier. If you own a home in our wonderful city, you may be eligible for our Budget Pay program. Enrolling in the Budget Pay Plan allows you to spread your utility payments into 12 equal monthly installments, providing predictability and peace of mind for your budget.

To take advantage of this opportunity, simply submit your request to City Hall by November 15th, 2023. However, to qualify for this convenient program, we kindly ask you to meet the following requirements:

1. Account History: You must have maintained a utility account with the City of McCleary for the past twelve months continuously.

2. Delinquency-Free: There should be no instances of delinquency during the past twelve months of your account history.

3. Current Account: At the time of your application, your utility account must be current.

4. Ownership and Residency: To qualify, you must be the owner of the residence and currently reside there. This program is designed to benefit homeowners who are actively living in the property.

We believe that the Budget Pay Plan can offer financial flexibility and convenience to our homeowners. It's our way of making your life a little easier.

If you meet these requirements and would like to enroll in Budget Pay, submit your request by November 15th, 2023.
