RESOLUTION NO. 504

A RESOLUTION ADOPTING AN AMENDED SIX-YEAR STREET PLAN FOR THE CITY OF McCLEARY.

RECITALS:

 The City Council and Mayor have received previously the recommendations of the City Engineer in relation to the requirements and programming involved with the six-year street plan; AND

2. In furtherance of those recommendations, the Council adopted Resolution Number 500 adopting a plan setting forth the proposed improvement program. Since the adoption of the resolution, additional review has been undertaken. Based upon that review, the City Administrator submitted an application for funding of that particular additional project relating to sidewalk improvement resulting in an extension of sidewalk for pedestrian use on 3rd Street.

3. To insure compliance, the Council wishes to formally adopt an amendatory schedule which includes the project for the identified project for which tentative funding has been received; NOW, THEREFORE,

BE IT RESOLVED AS FOLLOWS BY THE CITY COUNCIL OF THE CITY OF MCCLEARY, THE MAYOR SIGNING IN AUTHENTICATION THEREOF:

SECTION I: That certain listing of projects and the priorities established thereon attached hereto as Attachment Number 1 and incorporated by this reference shall be and is hereby adopted as the six-year street plan for the City of McCleary, as that plan is required and designated by the appropriate divisions and agencies of the State of Washington, including but not limited to the Department of Transportation and the Transportation Improvement Board.

<u>SECTION II</u>: The Clerk-Treasurer and the City Administrator shall provide such distribution of this Resolution as may be required from time-to-time.

SECTION III: This resolution and its attachment shall be deemed to supersede the provisions of Resolution Number 500.
