A RESOLUTION OF THE CITY COUNCIL OF THE CITY

R E C I T A L S:

WHEREAS, RCW 70.95 requires local government to prepare  
local solid waste plans based upon state guidelines; AND

WHEREAS, the City of McCleary has previously resolved  
to jointly plan with Grays Harbor County and the other cities and  
towns within the County for future solid waste management; AND

WHEREAS, the City has previously adopted by reference  
a prior draft of the Comprehensive Solid Waste Management Plan,  
and

WHEREAS, the County Solid Waste Advisory Committee and  
County staff have completed a draft revised Comprehensive Solid  
Waste Management Plan, which was distributed to all participating  
jurisdictions in August of 2001; AND

WHEREAS, the City has had the opportunity to review and  
provide input to the draft revised Comprehensive Solid Waste  
Management Plan; AND

SECTION 1: The City of McCleary hereby adopts by reference the revised Grays Harbor County Comprehensive Solid Waste Management Plan, July 2001, a copy of which is on file in the Office of the Clerk-treasurer, and further agrees to assist Grays Harbor County in implementation of the Plan in such ways as may hereafter be approved by action of the City.
