A RESOLUTION RELATING TO CLAIMS; DESIGNATING  
AN AGENT PURSUANT TO CHAPTER 119, LAWS OF

R E C I T A L S:

1. Pursuant to the provisions of Chapter 119, Laws of 2001, which amended RCW 4.92.010, the City was required to designate an agent to receive any claim for damages to be filed against the City.

2. The Mayor and Council have previously complied with the provisions of the law by making such a designation but find, for purposes of ease of reference and filing, that the ratification in a written form of the prior designation is appropriate.

SECTION IV: This resolution shall be deemed confirmatory of action previously taken by the City and its officials and officers and such actions are hereby ratified.
