RECITALS:

WHEREAS, the City Council and Mayor have previously adopted Resolution

No.376 defining the streets covered by the six year program of improvement; and

SECTION I: That certain listing of streets and the priorities established thereon attached hereto as Attachment Number 1 and incorporated by this reference shall be and is hereby adopted as the six-year street plan for the City of McCleary, as that plan is required and designated by the appropriate divisions and agencies of the State of Washington, including but not limited to the Department of Transportation.

SECTION II: The amended list adopted pursuant to Section I shall be deemed a successor to that certain listing adopted by Resolution No. 3% and this Resolution shall be deemed amendatory of that Resolution.

SECTION III: The Clerk-Treasurer and Director of Public Works shall make such distribution of this Resolution as may be required from time-to-time.
