

RESOLUTION NO. 402

A RESOLUTION AMENDING THE SIX-YEAR STREET PLAN FOR THE CITY OF McCLEARY; AMENDING RESOLUTION NO. 396; & AUTHORIZING SUBMITTAL THEREOF.

RECITALS:

WHEREAS, the City Council and Mayor have previously adopted Resolution No. 396 defining the streets covered by the six year program of improvement; and

WHEREAS, since the adoption of that resolution, certain conditions have been identified which, in the opinions of the Director of Public Works and the City's consulting engineer, merit review of the designations made by the cited Resolution; and

WHEREAS, the Mayor and Council have received the recommendations of the two officials in relation to the amendment of the Resolution adopting the current the six-year street plan; AND

WHEREAS, the Council and Mayor wish to formally adopt those recommendations as they have been established by the City Engineer subject to the modifications and expansions carried forth by the Council; NOW, THEREFORE,

BE IT RESOLVED AS FOLLOWS BY THE CITY COUNCIL OF THE CITY
OF McCLEARY, THE MAYOR CONCURRING:

SECTION I: That certain listing of streets and the priorities established thereon
attached hereto as Attachment Number 1 and incorporated by this reference shall be and is
hereby adopted as the six-year street plan for the City of McCleary, as that plan is required
and designated by the appropriate divisions and agencies of the State of Washington, including
but not limited to the Department of Transportation.

SECTION II: The amended list adopted pursuant to Section I shall be deemed
a successor to that certain listing adopted by Resolution No. 396 and this Resolution
shall be deemed amendatory of that Resolution.

SECTION III: The Clerk-Treasurer and Director of Public Works shall make
such distribution of this Resolution as may be required from time-to-time.
